Your <u>approval date</u> (which is indicated in your Homework Checklist email and is generally 1-4 days after you submit your purchase agreement) marks day #1 of your timeline; the timelines are detailed out in the Selection Service Levels below. We ask that you follow this Homework Checklist closely to ensure that your timeline stays on target. Our team will work alongside you to help keep you informed.

Please note that if your home is not finalized in the Home Creation Studio within the time specified in your selected Service Level below, your contract and pricing will be reviewed and is subject to change. Additionally, any approved changes made after finalizing will be considered a custom change and will incur a \$200 late fee per change.
